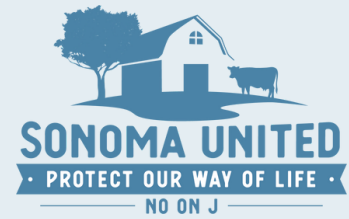

What is Measure J?

Measure J is an attempt by outside interests to eliminate dairy farming in Sonoma County by prohibiting farms and other animal production operations that have been in the county for generations and are vital to the future of this region.

Measure J is an assault on dairy farmers and the future of dairy production in California. The measure would have irreversible and devastating consequences on Sonoma County's agricultural economy and regional food security.

Anti-animal agriculture activists who wrote the ballot measure are attempting to mislead the public. Recently, the County Board of Supervisors was forced to intervene and correct deceptive language that inaccurately suggested the measure would improve animal welfare and water quality. How Does This Hurt Sonoma County?

Eliminating dairy production in Sonoma County would drive up the cost of food, devastate the local economy, kill thousands of good paying jobs overnight and wreak havoc on county budgets that fund police, fire and other vital social services. The ballot measure would negatively impact a variety of economic sectors related to the animal agricultural economy including, veterinarians, mechanics and farm and feed suppliers.

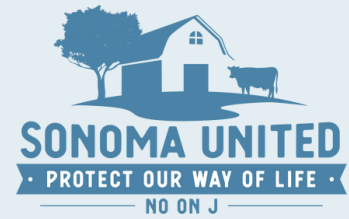
According to the University of California, eliminating dairy production in Sonoma County would result in the loss of \$259 million in agricultural production and reduce spending in the region by \$38 million.

Why Should People Outside of the Dairy Industry Care?

Sonoma County is a special place that offers a rural county feel with a rich agricultural history, vast open spaces and rolling hills that support wildlife and biodiversity. Sonoma is well known for its agricultural bounty, specialty grocery stores, world class farm to table restaurants, wineries and microbreweries, and a flourishing farmer's market scene offering fresh, organic and locally grown products including specialty dairy. Sonoma County dairy production is a key part of the agricultural system and is under attack by groups who do not share our values.

The organic scene in Sonoma County is supported by regenerative agriculture, a process that is led by local dairies providing the organic fertilizer used by hundreds of other organic business operations. Any organic product grown in the county was fertilized by the byproduct from an organic dairy or livestock farm.

If This Really Only Applies to a Few Large Farms, What's the Big Deal?

Measure J is an attack on Sonoma County's way of life by outside activist organizations imposing their extreme views on the residents of Sonoma. The impact of the ban will be devastating to our family dairy farmers, the dairy workforce and all professionals who service the agricultural economy.

County residents prefer products from farms that are pasture-based and engage in organic and environmentally sustainable farming practices. This includes local household names like Clover and Straus Creameries who adhere to the highest standard of care for their animals and provide local jobs, while protecting the environment.

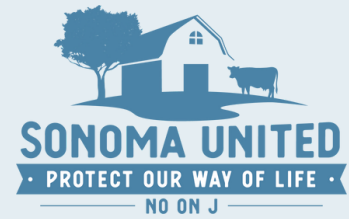

Who is Funding the Sonoma United Campaign?

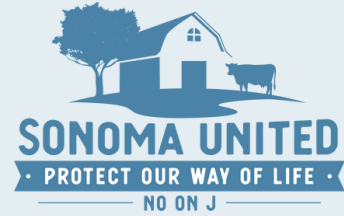
Talk about your support with your friends and neighbors and let them know how harmful this measure is and the effect it would have on the entire community.
